Teja, Coach of the Royal Fencing Academy, offered to sponsor a referee clinic. He was provided with information about the requirements for USFA sanctioned referee clinic.

**Continuation of Grants Programs:** It was agreed unanimously to: (1) continue the International Competition Grants and the Development Grants and (2) allow all university clubs to apply for a Development Grant each year.

**Ethical Conduct:** Given the amount of press about ethical conduct, violence, sexual harassment and bullying associated with sports activities, the Committee recommended that the Division develop a code of conduct that should be prominently posted in all Capitol Division clubs. Valerie had agreed to draft some language.

Post meeting, Ray informed the committee that he had contacted Lorrie Holmes, member of the US Fencing Board of Directors, to request that US Fencing Association develop and publish a SafeSport poster that can be displayed at all USFA clubs. She agreed to bring it up at an emergency meeting of the Board, scheduled for July 23. The results of this discussion have not been disclosed.

**Management of Capitol Division Fencing Competitions:** The Capitol Division would like to have individuals from more clubs participate in running the Division's tournaments. Katelyn Keegan has volunteered to be the referee wrangler. There is a need for more referees and bout committee managers. Several names were recommended and members agreed to follow up with them.

**Stipends:** The Committee had a brief discussion about stipends for referees, referee wranglers and bout committee managers. No changes in the level of stipends were recommended.
